Section 9 of our Constitution states "No capitation, or other direct, tax shall be laid. . . ." So, how can Congress write the 16th Amendment thereby changing the body of the Constitution and giving themselves more power?

"Congress cannot by any definition (of income in this case) it may adopt, conclude the matter, since it cannot by legislation alter the Constitution, from which alone it derives its power to legislate, and within whose limitations alone that power can be lawfully expressed.

"The 16th Amendment does not justify the taxation of persons or things previously immune. It was intended only to remove all occasions for any apportionment of income taxes among the states. It does not authorize a tax on a salary"

Section 8 of our Constitution states "The Congress shall have power to lay and collect taxes, duties, imposts and excises, to pay the debts and provide for the common defense and general welfare of the United States;" So, where does this out of control federal government get the power to spend us into bankruptcy?

Section 8 of our Constitution states "congress has the power to declare war;" Therefore every war since WW2 was illegal!

Section 8 of our Constitution states "Congress is to coin money, regulate the value thereof, and of foreign coin, and fix the standard of weights and measures;" So, where does Congress receive the authority to handover our gold and money supply to a unaccountable private corp. [the Fed] That prints money backed by nothing!

Section 8 of the Constitution says; To exercise exclusive legislation in all cases whatsoever, over such District (not exceeding ten miles square) as may, by cession of particular states, and the acceptance of Congress, become the seat of the government of the United States, and to exercise like authority over all places purchased by the consent of the legislature of the state in which the same shall be, for the erection of forts, magazines, arsenals, dockyards, and other needful buildings; So, how can this out of control government rob from the States and therefore the people almost 30% of the land and 100% of the water ways of the United States?

Section 3 of our Constitution states "the Senate of the United States shall be chosen by the legislature;" So, how can Congress write the 17th Amendment thereby changing the body of the Constitution and taking away power from the States and giving it to corrupt political parties?

Article II Executive power of the Constitution says "No person except a natural born citizen, or a citizen of the United States, at the time of the adoption of this Constitution, shall be eligible to the office of President;" So how can President Obama refuse and use the Courts to prevent We The people from seeing his birth certificate?

Article II Executive power Section 2 of the Constitution says; "The President shall be commander in chief of the Army and Navy of the United States, and of the militia of the several states, when called into the actual service of the United States" So, how can a President run a war when no war was declared by Congress and therefore the President was not called into actual service?
